Windows Upgrade Help Guide

On January 14, 2020, Microsoft is ending support for all editions of Windows 7 and Windows Server 2008/2008R2. Microsoft will no longer be releasing security patches and updates for these operating systems.

In order to continue receiving security updates from Microsoft a current operating system is required.

What This Means for You

Your patient data may be at higher risk on computers running Windows 7, Server 2008, or Server 2008R2 should you continue to use these outdated systems past the Microsoft end of life date. According to the Department of Health & Human Services, any known security vulnerabilities of an operating system should be considered in your <u>risk analysis</u>:

 Be sure to have a plan in place to update your server and workstations to a current operating system, i.e. Microsoft Windows 10, or Microsoft Server 2012 or newer

Using your local IT resources and/or Microsoft, you must determine the correct Windows 10 or Windows Server licensing, installation, or upgrade process for your business.
